Dear Parent/Carer/Guardian

There are sometimes occasions when we wish to take photographs or make video recordings of children at our Club. Sometimes this is for strictly educational and training purposes. On other occasions it may be for other purposes e.g. taking photographs for use on the Club web site, for Publicity situations such as newspaper articles when reporting or covering events we attend or hold. These will never include photographs which show full length images of children in swim suits and the photographs where possible will be group shots which should be head and shoulders or full clothed (ie wet suits) or action shots in the water. There will be no names, addresses, ages or schools mentioned without prior warning.

Conditions of Application – OPEN WATER 2010

In line with recommendations in Lifesavers Child Protection Policy the promoters of this event request that any person wishing to engage in any form of Video or Photography (including mobile phone technology) should register their name and address with the event organiser (Broadway and Failsworth Life Saving Club) before carrying out any such photography.

The promoter reserves the right of entry to this event and reserves the right to decline entry to any person who is unable to meet or abide by the promoters conditions. Please mention the above requirements to parents, family and friends who may be attending the sessions.

- It is imperative that all session begin promptly. Please arrive on time.
- A small number of wetsuits (for the younger members) can be borrowed for the open water seasons only, for an **non-refundable charge of £5.00**, from the club on a first come first served basis
- Do not enter the water unless instructed by your trainer/examiner
- Appropriate clothing must be brought for each session (i.e. Wetsuit/yellow t-shirt/quartered hat)
- Suitable footwear must be worn at all times
- Please notify the club if you (or family) intend to use a camera or video (see above)
- NOTE – A minimum of 5 Open Water sessions (all sessions must be attended for Beach Lifeguard) must be completed for any award plus theory to equal the total number of training hours required.
- Assistant Beach and Beach Lifeguards Awards -these will only be awarded at the end of the open water (season) to the candidates with the required number of training/ open water attendance hours, including theory.
- Please book early as under the recommendation of the risk assessment, numbers will be limited.
- Risk Assessment– please do not turn up on the day as place numbers are limited and strictly for applicants only
- Please make sure that all information required is complete, as incomplete booking forms will be rejected.
